


- (4) Education to cultivate human resources with social responsibility for common peace and prosperity in human society







# Study Abroad Programs

---

Kyung Hee University has signed a Memorandum of Understanding with over 380 sister universities across 65 countries, including Harvard University, Keio University, Cambridge University, the University of British Columbia, and Renmin University (<http://oiak.khu.ac.kr/>). This vast array of excellent universities provides exemplary opportunities for GSP students to study abroad, either as exchange or dual degree students.

Every year, GSP sends around 5–10 students to study abroad with generous financial support. Those participating in the exchange program or dual degree program only pay tuition to GSP and are exempt from paying tuition to the host university. Likewise, foreign exchange students wishing to study at GSP only pay tuition to their home university and are exempt from paying tuition to GSP.



# Study Abroad Programs

## Student Exchange Program

This program allows GSP students to study abroad for one or two semesters at one of our excellent sister universities. Our partner universities include but are not limited to:

## Dual Degree Program

Students participating in this program can study abroad in one of GSP's sister universities for two semesters. The benefits of our dual degree program are that students can earn two master degrees, one from GSP and another from the partner university in two years. ## Oxford Human Rights Consortium

The Oxford Human Rights Consortium holds an annual workshop in collaboration with the Oxford Institute for Ethics, Law and International Peace (ELAC) and its faculty. A workshop is held every year for students and faculty and consists of various topics such as international peace, technological cooperation, climate change, and human rights.

# Oxford Human Rights Consortium

## Oxford Human Rights Consortium Activities

The Oxford Human Rights Consortium is a network of 15 US universities that offer regular workshops on the human rights movement on a variety of topics. The consortium hosts two workshops each year in Oxford and a variety of online webinars and workshops. In addition, it is currently expanding its university network into Brazil and Ghana. As of 2022, the consortium already has an alumni association of over a thousand students.



## Oxford Human Rights Consortium Workshops

A representative workshop held every March in Oxford, England, is a week-long spring seminar focusing on human rights and humanitarian law. In addition, the consortium will hold seminars on various topics, all of which are related to global issues such as world peace, climate crisis, COVID-19, ethics, technical cooperation and human rights.

Graduate students from the Graduate School of International Studies participate in seminars on a variety of topics at the Oxford Human Rights Consortium.



# Graduate School of International Studies Summer/Winter Workshop

The Graduate School of International Studies is strengthening research capabilities and fostering a global academic culture through summer/winter workshops.

# Graduate School of International Studies Summer/Winter Workshop



## Career Development Internships

GSP emphasizes pragmatic learning methods and internships, which provide a great opportunity to bridge the gap between theory and practice and to gain exposure to professional opportunities. Through internships, students are able to integrate and use their knowledge from classes, develop further competence through intensive field experience under educational supervision, and become better acquainted with the various work places and setting in which they expect to be employed. Therefore, GSP places particular emphasis on internship and especially on international experience.

All students are encouraged to undertake internship before graduation. Students who undertake overseas internships can earn academic credits as well as receive financial aid from GSP. GSP also recognizes that getting internships can be a daunting task to students. Therefore, it runs a unique support program for internships called KISS (The Kyung Hee International Internship Support System) which manages student internships in three stages: identification, implementation and evaluation.






